In terms of Regulation 29 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that a meeting of the Board of Directors of REC Limited will be held on **Friday, May 13, 2022** *inter-alia* to consider and approve audited financial results (standalone & consolidated) of the Company for quarter and year ended March 31, 2022 and declaration of dividend, if any.

Further, it is informed that as per Company's code of conduct for regulating, monitoring and reporting of trading by designated persons and their immediate relatives; and as informed vide our letter dated March 31, 2022, the trading window is closed from April 1, 2022 till expiry of 48 hours after the declaration of the financial results for the quarter and year ended March 31, 2022 for trading in REC equity shares and listed debt securities (tax free bonds etc.) for all designated persons and their immediate relatives.

In view of the above, the period of closure of trading window for trading in REC equity shares and listed debt securities (tax free bonds etc.) will be from April 1, 2022 to May 15, 2022 and trading window will open with effect from May 16, 2022.
