In terms of Regulation 30 read with Schedule III of the SEBI (LODR) Regulations, 2015, it is informed that Shri Ajeet Kumar Agarwal (DIN 02231613) Director (Finance) who was also holding additional charge of the post of Chairman & Managing Director, REC Limited has superannuated from the services of the Company on May 31, 2020 and has ceased to be a Director on the Board and Key Managerial Personnel, of REC Limited (Formerly Rural Electrification Corporation Limited) with effect from June 1, 2020.

Further, pursuant to Office Order No. 46/9/2011-RE [228164] dated April 21, 2020 (**copy enclosed**) of Ministry of Power, Shri Ajoy Choudhury (DIN: 06629871), presently Executive Director (Finance), REC Limited has been appointed as Director (Finance) on the Board of REC Limited with effect from June 1, 2020 till the date of his superannuation i.e. January 31, 2024 or until further order, whichever event occurs the earliest. Shri Choudhury is not *inter-se* related to any other Director of the Company. Further, as per declaration given by him, Shri Choudhury is not debarred from holding the office of Director by virtue of any SEBI Order or any other such authority.

He was earlier working in senior management position in REC and has handled a gamut of finance portfolios such as International Finance, Contracts Management, Loans & Recovery, Corporate Accounts, Resource Mobilization & Treasury etc. He has been instrumental in implementation of various systemic improvements including formulation of Loan Recovery guidelines, improving communication and services to customers and managing overall Resources and Treasury in REC in an efficient manner. He has been a member of Core Team for implementation of ‘Ujwal Discom Assurance Yojana’ (UDAY), flagship programme of Government of India, aimed at turnaround of Distribution Companies in the Indian Power Sector.




